4. Reason for Election

As announced in the "Announcement of Opinion Regarding the Tender Offer for the Company's Shares by Yahoo Japan Corporation" dated September 27, 2019, the Company agreed, in the capital and business alliance agreement executed with Z Holdings Corporation ("Z Holdings Corporation", whose corporate name was changed from "Yahoo Japan Corporation" on October 1, 2019) on September 12, 2019, to take the procedures to elect one person nominated by Z Holdings Corporation as a director of the Company at the Company's extraordinary general meeting of shareholders to be held as soon as practically possible after the consummation of the tender offer for the common shares of the Company by Z Holdings Corporation.

Pursuant to such agreement, Mr. Kawabe was nominated by Z Holdings Corporation as a candidate for the director of the Company and Mr. Kawabe has abundant experience and broad knowledge cultivated in the Internet services industry. As the Company has concluded that electing Mr. Kawabe as a director of the Company will contribute to strengthening the capital and business alliance with Z Holdings Corporation and promoting the smooth implementation of such alliance with Z Holdings Corporation and its group companies, the Company determined Mr. Kawabe as the candidate for director.
